Education Committee: No Report

Ethical Practices Committee: Robert MacFarlane suggested that a survey be made as to what approach Surveyors are taking when researching a property for survey. The Board was in agreement with his suggestion.

Motion was made by Robert MacFarlane that he would approach the Saratoga Historical Society and offer a survey of their property by members of the Eastern New York State Society of Land Surveyors, Seconded by William Schafer, Passed.

Goedetic Control Committee: Robert Allen reported that Paul Male had not contacted Ed Tracey yet to see what action has been taken on our changes and recommendations to the existing local law.

Mr. Tracey has agreed to the use of the auditorium at the Saratoga County Municipal Center for our up-coming seminar and will speak on the law concerning the Monumentation Law.

Paul hopes that some sort of compromise to the law would be in effect prior to his talk at the seminar.

Eastern New York Flyer Committee: No Report

Continuing Education Committee: The proposed State Plane Coordinates Seminar is scheduled for June 10, 1977, covering the use and theory involved in utilizing the State Plane Coordinates System. Additional topics to be covered are the functions of the U.S.G.S. and N.G.S. (U.S.C. & G.S.) and where to find the data and control that such agency supplies to the public.
