## PRESIDENT'S REPORT

October 11, 1995

The NYSAPLS Board of Directors meeting was held Friday, September 15, 1995 at 1:00 P.M. at the Inn at the Century, Latham, NY.

President Ennis sent a letter on behalf of NYSAPLS to the Onondaga County Bar Association regarding an attorney that requested an updated survey without field work being necessary.

President Ennis, Joann Crum and others met with the Department of Labor Public Works Advisory Board to explain the role of the Land Surveyor for prevailing wage rate Consulting Engineer Survey Work. Attempt was made to define the role as a professional service not to be classified as laborers, mechanics or workmen as defined by the Attorney General.

At time of meeting about 2800 letters had been sent out for requests of donations to PAC fund. Volunteers led by Jim Delano, put the mailing together and financed it as well. As a result about \$7000 had been collected so far.

Mona Glanzer reported that under a new state law professional licenses can be suspended for failure to pay child support over a period of for months.

Education Committee reported that scholarship forms were mailed in September. The committee has been in contact with SBELS about possible topics for seminars at conference. Ideas for seminars are still wanted. Attempts will be made to get seminars held by NYSAPLS accredited in other states. Genesee Valley is to cosponsor a seminar in spring.

Nomination Committee had the following candidates for officers, President Jim Delano, ExVP Bob Green, VP Bob Prescott and Bob Marvin, Treasurer Marie Welch, Secretary Bob Smith. Written petitions were still being accepted.

OPD is preparing a training film for its investigators. Meetings have been held with members of OPD, AIA, PE's, NYSAPLS and others to try and determine what types of

questions should be asked by investigators. Number of investigators is dropping from 97 to 57, may be down to 37 before next April. 7 survey cases have been investigated during past 30 months.

GIS in Local Government Commission held first and last meeting in September. However committee members agreed to keep the commission together and to deliver a report by March 1.
