Larry suggested writing a letter thanking them for the changes they have made to date and letting them know that they are close to being in violation and that we would continue to monitor the situation.

Another member suspects another company is offering land surveying practices illegally

• The second company is not an ENYSLS member. There seems to be enough disclaimers of "This is not a survey" on website.
