New Business:

• Do Treasurer and Secretary need to be board members? Article III, Sec 2(c). "If the presiding officer at a meeting of the Board is not a Director, they shall hereby be authorized to case a deciding vote, only in the case of a tie" Is this to refer to the Past President? By-laws Article II Section 2 (b) For the purpose of transacting Board business, a quorum shall be defined as a majority of the total number of Directors. By-laws Article IV Section 2 (b) - For the purpose of transacting Society business, a quorum shall be defined as a majority of the Board of Directors and at least 50% of the average number of attendees from the three

preceding General Membership Meetings. A discussion was held, and it was noted that the definition of a quorum for General Membership Meetings was revised to follow the model adopted by NYSAPLS however the definition of a quorum for BOD meetings was not revised. After discussion, it was decided to leave the BOD Meeting quorum definition as it stands.

• Elections- Ballots need to go out 20 days prior to the meeting if we are amending by-laws or 2 weeks if not. Ballots would need to be in hand by 10/21 or 10/27
