### EASTERN NEW YORK SOCIETY OF LAND SURVEYORS BOARD OF DIRECTORS MEETING February 9, 2023

The Mill Round Lake, NY

President Meisler called the meeting to order at 5:41 p.m.

#### Secretary's Report: Jason Tommell

• Jason was absent, Dwayne Cooper presented the December proposed meeting minutes. A motion to accept the December meeting minutes was made by Lucas Boyer, seconded by Rick Palmer. A vote was held, and the motion passed.

#### Treasurer's Report: Jim Vianna

- Jim provided an update on the LPL account balance and the Bank account balance.
- There were expenses of \$2,000 from 2 of the scholarship checks.
- Income in the amount of \$60 (NYSAPLS dues).
- Jim reported that he received a donation for the Hartnett Scholarship fund from the Watsons.

#### MTS Report: Jim Vianna

• Jim reported that there was a meeting held on February 7, not much is going on with committee. Jim said that he will present the MTS program at the general membership meeting in March.

#### President's Report: Brie Meisler

- NYSAPLS Meeting 1/17/2023 and 1/20/2023
- Membership committee noted that membership is up due to associate members, but membership revenue is down because associates pay so much less.
- Report from a representative of the organization handling investment accounts is hopeful that we will see a normalizing of the market soon.
- There has been continued effort to reinvigorate regional and representatives were in attendance from Alleghany, Central, and Southern Tier.
- Revenue from exhibitors was below budget. Several entities had combined such that what used to be 2 booth sales was only one.
- A virtual meeting was held 12/7 with Mark Casellini from DOT. They have agreed to give NYSAPLS records for one county with hope that if we can present the information back to them indexed they may provide more. Plans for developing a GIS database were discussed.

- SBELSG is seeking volunteers to serve.
- Tim Burch, Executive Director of NSPS attended the meeting. He spoke highly of the social media content that NYSAPLS produces and says they often share our posts. He also mentioned that NSPS is looking into a salary study, but that with a response rate of 13% on the last request for input from membership, they are reluctant to launch a study with such low participation
- Motion was made to disband The Ad Hoc Minimum Technical Standards committee. Roy countered that the committee had tasks set by the approved Strategic Plan Report and therefore business of the committee was not complete.
- In person conference was a success. There were 742 registrants, including walk-ins.
- Two of our own were map contest winners. Congratulations to Jason Peterson and Jim Vianna!

#### Executive Vice President's Report: Jason Peterson

• Jason reported that the Fort Drum Career Fair was last week. He reported that there was a lot of interest in drone operation after separation from the service by attendees. Overall, he said the feedback from attendees was very positive. He noted that there were 50-70 vendors presents.

#### Vice President's Report: Lucas Boyer

- Lucas reported that the March meeting will be held at Ravenswood. They have a \$23 one entrée option and a \$27 two entrée option.
- A discussion was held on raising the fee for dinner meetings to \$30. Due to the rising costs, it is getting difficult to find venues that are under \$25 for meals. A motion to raise the General Membership Meeting fee to \$30 was made by Jim Vianna, seconded by Jason Peterson. A vote was held, and the motion passed.
- There was a discussion was held on bringing back the 50/50 raffle. A motion to have a trial run 50/50 raffle at the March Membership Meeting was made by Lucas Boyer, seconded by Luke Richardson. A vote was held, and the motion passed.
