MINUTES

EASTERN NEW YORK SOCIETY OF LAND SURVEYORS BOARD OF DIRECTORS MEETING February 8, 2024

The Mill Round Lake, NY

President Meisler called the meeting to order at 5:52 p.m.

Secretary's Report: Dwayne Cooper

• Dwayne presented the December proposed meeting minutes. A motion to accept the December meeting minutes was made by Kaleb Winters, seconded by Rick Palmer. A vote was held, and the motion passed.

Treasurer's Report: Jim Vianna

- Jim provided an update on the LPL account balance and the Bank account balance.
- Income in the amount of \$3,110 (\$110NYSAPLS dues and \$3,000 transfer from LPL for scholarships).

- I attended the NYSAPLS BOD meeting on 1/16/2024 and 1/19/2024.
- The conference exceeded budget projections.

- On the recommendation of the Ethical Practices committee, a member was suspended for 3 years for signing plans for several companies that were not registered to practice within the NYS.
- The legislative committee reported that they have received clarification that students who are unable to obtain the necessary credits for licensure through a matriculated program could complete the course work elsewhere as long as the required subject matter is covered.

Old Business:

• Jim made a motion to amend the December motion for a \$100 donation to Saratoga Plan and amend it to purchasing a NSPS Final Point for C. Donald Carpenter in lieu of the original motion, Kaleb seconded the motion. A vote was held, and the motion passed. Jim reported that he had been in contact with Art Carpenter about a location for the final point. The cost of the Final Point marker is going to be about \$135, Jim said that he would cover the cost over the \$100 ENYSLS donation. Saratoga PLAN said that they would advertise the date and location of the dedication ceremony when it has been set.

New Business:

- Annual audit. Dave volunteered to conduct the annual audit.
- Domain Renewal. The domain name renewal is due by March 17, 2024. A discussion was held, and the conclusion was to renew the domain name for the maximum period offered (nine years) at a total cost of

\$163.53. Jim made a motion to renew the domain name for nine years, Dave seconded. A vote was held, and the motion passed.

- CST exam. A discussion was held about ENYSLS hosting a CST exam. Dwayne is currently approved by NSPS as a CST proctor and Brie agreed to submit an application to be approved as a proctor too. A discussion was held about the value of mailing a letter to the heads of the members on the proprietors list as well as a general email to the entire membership advertising the exam. A motion for ENYSLS to pay for postage to mail a letter out to proprietors was made by Dave and seconded by Jim. A vote was held, and the motion passed.
- Program for March. Jim agreed to give a presentation on the Binding Arbitration process that Northern has adopted.
- Kaleb reported that Alfred A. Major's records were held by Ferguson & Foss.
