COMMITTEE REPORTS:

rogram Committee: William A. Schafer, Chairman, announced that Harold A. Jerry, Jr., Speaker, will talk on A.P.A. at our next general membership meeting.

Constitution and By-Laws Committee: Christian P. Momrow, Chairman, gave the Board a report on four (4) proposed amendments to our Constitution and By-Laws for our 1979 annual meeting, along with their projected 1979 Committee Budget.

Membership Committee: Christian P. Momrow, Chairman, stated that applications for membership have been received from the following to be acted on at the regular meeting in November:

Chris asked the Board of Directors to consider a change in the dues structure to affect new members; i.e., on members voted in at the September or November meetings to have their dues check also apply to the following year with no additional fees required.

The Board was in complete agreement with Chris's proposal of holding the State dues over to the next fiscal year.

Continuing Education Committee: Robert Allen stated that possibly next fall, we would cossibly have a seminar on a court case pertaining to surveying.

Bob announced that their budget for the fiscal year 1979 would be zero dollars.

This self-sustaining committee has done an outstanding job for our society and profession.

President's Report: Bob stated that our society needs new members and asked the member-ship to consider the personnel working for them or whom they may be acquainted with that possibly if approached would join the association.

Bob announced that ACSM was requesting financial aid from the State and Survey Societies. It was the consenus of opinion of the Board that this aid should be supported individually not by the society as a group.

Bob announced that the New York State Department of Transportation has a bound Copy of Roads in Central New York State giving names, right-of-way width, etc., for sale. Paul Tommell was going to investigate the matter.

New Business: Harold Behrens, Jr., stated that he would like to see that when surveyors obtain information from other surveyors, that when their job is completed, a copy of the new or adjacent survey be sent to them.

Paul Tommell, in conjunction with Harold's concern, stated that the Real Tax Department should also be provided with new surveys and be notified of any errors that surveyors may find. They have been very helpful in providing information to us and have been receiving very little in return.

Paul Tommell expressed his concern, with a possible problem concerning all surveyors, over the possibility of law suits pertaining to persons becoming injured along survey cutting lines.

It was the consensus of the Board that all future Board of Directors meetings would be held at the Silver Spur in Latham. Their meals are fairly reasonable, good service, etc.

Our guest, Louis Charland, approached the Board on benefits for people belonging to the association, such as discounts on dishwashers, refrigerators, cars, etc. Louis also discussed the possibility of a manpower pool where if men are needed for a job, or if a man is laid off due to hard times, he or the survey company can appeal to the manpower group or committee for men on jobs.

The Board of Directors informed Lou that both ideas sounded interesting, and that upon further research at no obligation, commitment, or expenditure of monies to the society, eport his findings to the Board.
