Motion by Robert Walsh, second by Robert Allen, to accept the Secretary's report as mailed: - carried.

Harold Behrens, Treasurer, presented his report to the Board and stated that there has been a problem in collecting dues for this year.

Motion by Rodney Michael, second by William Schafer, to extend to August 1, 1982 the final date for payment of 1982 dues without penalty: 6 x 6 deadlock.

Motion by David Butler, second by James Allen, to extend to August 1, 1982, this year only, the final date for payment of 1982 dues without penalty: 7 for 5 against - carried.

Rodney Michael suggested that the Constitution & By-Laws Committee look into changing the deadline for payment of dues. Rod also suggested that the Committee look into the problem of associate members obtaining their license and not applying for reclassification of membership status to senior.

- 5. A presentation of a Health Insurance package was made by James Hutchins from "American Industries Insurance Trust Funds" from Syracuse. the rates were as follows:

The Insurance Committee is solicitating names of Attorneys in all parts of the state to represent the E & O carriers in the defence of claims against surveyors.
