- 1. Northern New York Association of Professional Land Surveyors was affiliated pending review of their Constitution and By-Laws by Counsel.
- 2. It was reported that NYSAPLS has lost 31% of its sustaining members during 1982.
- 3. A note of interest on mechanics liens. If filed on multi-family unit, one has 8 months from date of last work to file the lien. If filed on a single family dwelling, one has 4 months to file.
- 4. Weschester County Health Department has refused acceptance of plans designed by L.S. with "N" Exemption. Counsel to send letter demanding that they accept the plans in question and response to be made to that effect to be made within two weeks or counsel has been directed to begin litigation.

The North Greenbush Planning Board is not accepting Subdivision Plans without the stamp of a P.E. President Momroe has been placed on this month's Town Board workshop meeting agenda to discuss this policy with them and the Town Attorney.

A letter has been received from Charlie Hartnett inquiring as to what the remaining proceeds from the 1981 Highway Law Seminar were to be used for. Since the matter of whether Southern Tier is to receive a share of the proceeds has not been settled, a motion was made by Rod Michael that the remaining proceeds be placed in the General Fund until that time President Momroe negotiates with Southern Tier and resolves their claim to the proceeds. Any settlement (not to be greater than that which was authorized at a prior meeting) would come from the General Fund. Motion seconded by Paul Hite - carried.

NEW BUSINESS
