NYSPE addressed the Board of Regents regarding the "n" exemption. They do not support the extension of the exemption to other land surveyors.

Delaware - Hudson Land Surveyors stated that Orange County passed a law requiring all subdivisions to have an engineer's seal.

The Education committee passed out a questionnaire on the attitudes of the land surveying community on continuing education as a requirement for re-registration in New York. This is based on a Texas questionnaire and contains 40 questions. \$1000 was appropriated from the Shaw Fund to finance this study.

Scholastic Development Committee:

The committee has recommended that the award for this year be more than \$800. Motion by Bill Nettleton that the scholarship award for this year be \$1000 plus \$100 to cover the annual conference expenses, second by Bill Lucarelli: carried.

32nd Annual Conference:

First organizational meeting was held. More volunteers are still needed. Committee will be meeting on a monthly basis.
