### President's Report:

#### NYSAPLS Concerns -

The September meeting of the NYSAPLS Board of Directors will be held at the Inn at the Century, Latham, N.Y. on September 20-21.

NYSAPLS Secretary James Delano reported that following a formal resolution by NYSAPLS at their May meeting concerning the expanded scope of practice for land surveyors, the NYSSPE Board of Directors passed a similar resolution. The PE/LS ad hoc committee is working to formalize a proposed submission to SBELS.

Memorandum received from Mona Glanzer, NYSAPLS legal counsel, stated that in May of 1991 the appellate division ruled on the subject of prevailing wage case holding that the failure of the Commissioner of Labor to supply current wage rate schedules to an employer would not relieve the employer from paying the prevailing wage rate.

Business Practice Committee:

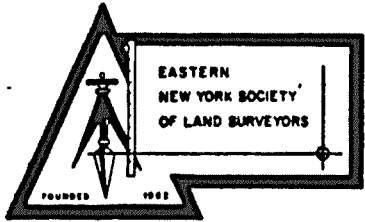
